### Abstract

This guide instructs you on how to use the **EU SDG Profile Creator 2025.2** application, to create profile for an EU SDG indicators set.

# Chapter 1. Getting started

## Introduction

In 2015, the United Nations (UN) together with international and national stakeholders adopted the 2030 Agenda for Sustainable Development. The defined 17 Sustainable Development Goals (SDGs) and 169 targets demonstrate the vast scope of this new Agenda. Additionally, in order to measure progress towards the SDGs in an EU context, the European Commission has developed an EU SDG indicator set distinct from the global UN list. The **EU SDG Profile Creator** is the desktop application that is aimed to create one document, profile, in a common Microsoft Excel format. This document contains in one place all the data for the EU SDG indicators, retrieved from the Eurostat database, and presented in the forms of the tables and charts. Each indicator is shown on separate Excel sheet. Additionally, it also offers the option to create the summary statistics to review the availability of data for an EU SDG indicators set, for selected country.

This application uses new API Statistics Web Services that are being offered by Eurostat at their web site, at address <https://ec.europa.eu/eurostat/web/main/data/web-services>. By using those free services, data for the EU SDG indicators are directly retrieved from the Eurostat database and formatted appropriately in an excel document.

## Application requirements

The application **EU SDG Profile Creator 2025.2** is the **Windows desktop** application. The hardware and software requirements are the following:

- PC with Intel (x86/x64) processor, minimum 4GB RAM memory
- Windows 7 or higher version
- MS Office Excel 2007 or newer version
- Active Internet connection

## Installation

You can use this software in two ways, either to install it or use the portable version. The installation is very simple and is done in a few simple steps. The **Installation Manual** contains the detailed information on where to find the setup program and how to install this tool. After the installation, the new icon will appear on your desktop, as shown below.

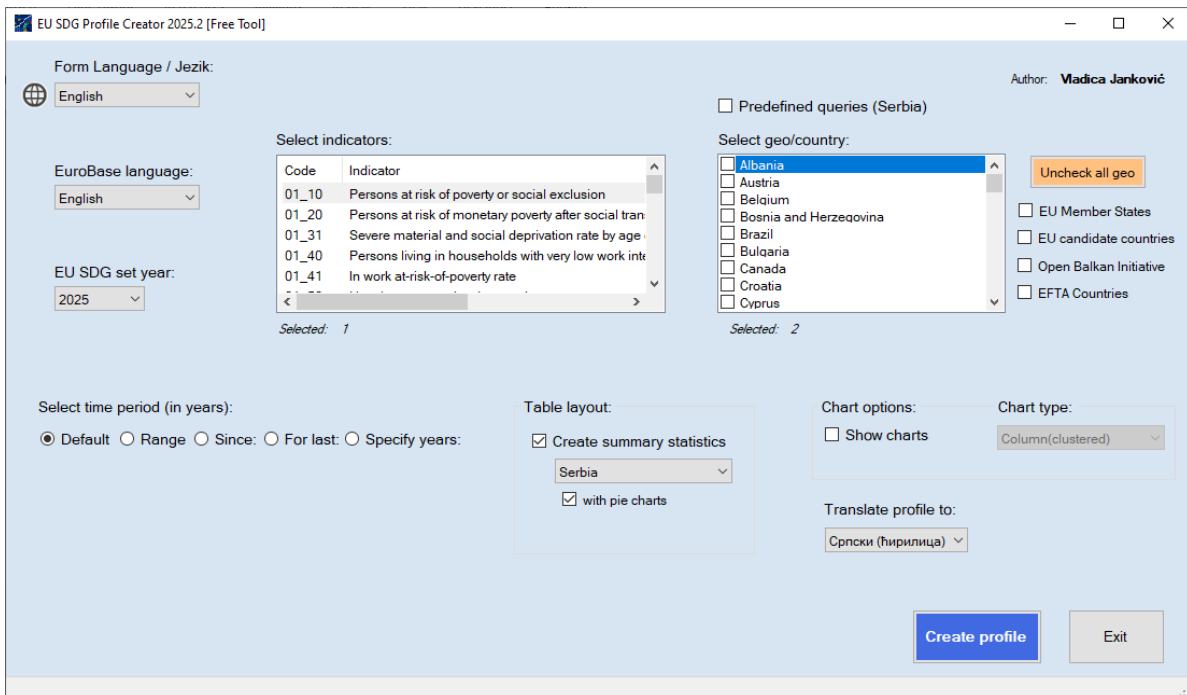
The portable version offers to run the program **EUSDGProfileCreator.exe** from the portable tool folder.

# Chapter 2. Creating EU SDG profile

The application **EU SDG Profile Creator** offers access to data on EU SDG related indicators in an easy way and in one place. Begin by first starting the application from your desktop and then select the parameters that you wish to search data for in the Eurostat database, in order to create the profile.

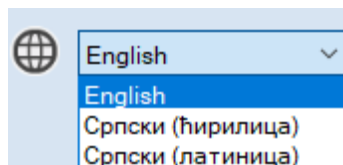
## Selecting parameters

When you start the application you will get only one form. That is the place where you can choose all the parameters that are needed for the creation of the profile. This form is shown below.

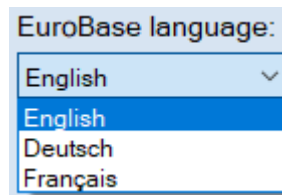


The explanation of each element on the form follows:

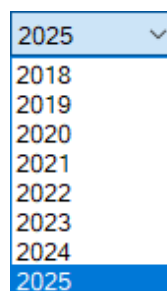
- The dropdown list in the upper left corner gives you the option to choose between two languages **to be shown on the form**. These are English (default) and Serbian (Cyrillic or Latin Script). See the picture below.



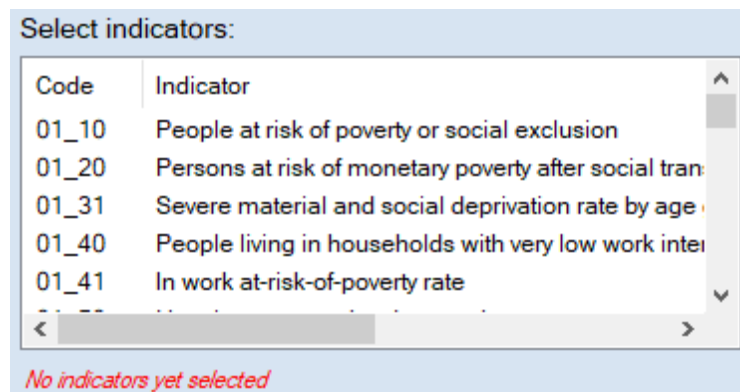
- The drop down list **EuroBase language:** gives you the option to choose between three languages offered on Eurostat web site: English, French and German. The English language is selected initially. Note that the indicator names, units and parameters in the created profile will be shown in the language selected here. *See the picture below.*



- The dropdown list **EU SDG set year:** gives you the option to choose the year for the official EU SDG indicators set, starting from 2018 onwards. The most recent year 2025 is selected by default. *See the picture below.*



- Based on the selected year, the application will show (fill-in) all official EU SDG indicators for that year. For example, if 2025 is selected this list will contain all the indicators for 2025 year. *See the picture below.*



At least one indicator must be selected in order to create the profile. This list enables the selection of many indicators. For example, you can select all the indicators from the SDG Goal 1 (indicators which codes have prefix 01\_) and then indicator 12\_10 etc. To select all indicators from the list, press Ctrl+Shift+End simultaneously on the keyboard.

- The check box list **Select geo/country** gives you the option to select one or more geo parameters (countries). At least one geo/territory must be checked. Initially, **European Union – 27 countries (from 2020)** and **Serbia** are selected, but it can be changed easily. *See the picture below.*

The button **Uncheck all geo** clears (reset) the selection. The check boxes on the right side enable quick adding or removing the group of countries from the list. For example, if check box **EU candidate countries** is marked, then Albania, Moldova, Montenegro, North Macedonia, Serbia, Türkiye and Ukraine will be selected.

➤ You can select time period(s) by choosing one of the five radio buttons under heading **Select time period (in years)**. These are:

- a) If the option **Default** is chosen, all available data (all years) for the selected indicators and countries will be retrieved from the Eurostat database.
- b) The option **Range** offers you to choose the year range. The data for the years in range will be retrieved. In the example below, all the data from 2010 to 2015 will be selected from the database.

- c) If the option **Since** is chosen, the data from the selected year onwards will be retrieved from the database. In the example below, all data starting from 2010 will be selected from the database.


- d) If the option **For last** is chosen, the data for last available number of selected years will be retrieved from the database. In the example below, the data for last five years available in the database will be selected and retrieved.

- e) With the option **Specify years** any combination of years could be made. For example, the range of years 2010-2015 and 2019. Click on the button **Reset years** to clear the selection and start over.

- If the check box **Predefined queries (Serbia only)** is marked, the application will create the profile based on existing data for Serbia. For example, the data for SDG indicators from EU-SILC will be available from 2013 onwards etc.

Predefined queries (Serbia only)

- The section **Table layout** offers the possibility to create summary statistics (availability of data for SDG indicators) for the selected country. In the example below the selected country is Serbia, but it can be any country from the list. The summary statistics that application generates will be located on the last excel sheet named **SUMMARY STATISTICS** in the created profile. If the field **with pie charts** is not selected (checked), the summary statistics will not contain pie charts (to the right of the summary table).



- The section **Chart options** offers to choose to show or not the charts in the created profile. If you want to get only tables, the check box **Show charts** should not be checked. Further, you can select the type of the chart to create, among six different types offered (see the picture below)



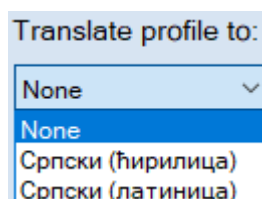

- The dropdown list **Translate profile to:** offers to get profile translated into Serbian language (Cyrillic or Latin script). If **None** is selected here, the profile will be created in the language selected in the dropdown list **EuroBase Language**.



**Important note:** You can select previously explained parameters in any order

Create profile

After you select all the parameters, click the button **Create profile** to create the profile. The application will show the progress bar at the bottom of the form. When finished, just select the folder location and the name to save newly created EU SDG profile. That is all!

**Note:**

*You must have Internet connection in order to get the data and create the profile!*

There are many different ways how you can select parameters, i.e. to define what profile you want to create. For example, you can select only indicators from the SDG Goal 1 (indicators with prefix **01\_**), some EU member states and candidate countries, years 2015-2021<sup>1</sup>, chart type line with markers or similar etc.

## Viewing profile

The profile is an Excel document, created in xlsx format. Each EU SDG indicator is placed on separate sheet. The number of excel sheets depends of the number of selected indicators. See the screenshot below.



The sheets are colored, by default, in UN standard colors defined for SDG goals.

**The CONTENTS tab enables easier navigation within the profile, as it contains in one place hyperlinks to all indicators in the profile.**

The example below illustrates the profile created for only one indicator that is **01\_10**, in order to compare Serbia and EU 27-countries in the period 2015-2023.

The first row contains the name (short version) of the SDG Goal that is **1. NO POVERTY** (as given on Eurostat web site). Following below is the small table that contains the information for the indicator: name (label), code (**01\_10**) and direct links to Eurostat database to tables with data, metadata and link to download the data in **tsv** format. Then, below is a table with information useful for monitoring this indicator: **Trend**, **Target Value** and **Target Year**. Here it can be seen that for this indicator it is better (desirable trend) when there are smaller values (Less is good), which means that

poverty is reduced. Furthermore, by 2030 (the target year), the number of poor people in the European Union should be reduced by 15 million, including at least 5 million children (Target value defined by the European Commission).

Further, on the left side going below are the generated tables with all the available data. In this example there are four tables, two for the whole population and two for the population less than 18 years, and the values are showed in two units **Percentage** and **Thousand persons**. Each table header contains the name of the indicator, time period(s) and unit. Subtitle contains additional parameters specific for the table.

For each table there is an associated chart (here line chart with markers) on the right side. **Please note that the excel chart is pure object (not picture)** and allows easy further customization and use in other applications.

Below the last generated table is additional information for this indicator: the data source, dataset name, the date when the dataset was updated and the meaning of flags. Finally, at the end is the short description (metadata) for the indicator. **All this information is retrieved directly from the Eurostat database and it is the state in the moment when the profile was created.**

Some data points could come with flags. Those flags are visible in the table within the comment textbox that you get when you keep mouse over the table cell that has associated flag(s). See example below for the indicator **04\_20**, with explanation below the table that the mark **b** means that in 2021 there was a break in the time series.

If there are more flags for some data point in Eurostat database all will be shown in the comment textbox.

## Summary statistics

The application can create the summary statistics on the data availability for the EU SDG indicators, for the selected country and year. The generated table on the sheet **SUMMARY STATISTICS** contains detailed information for all SDG goals: the total number of indicators per each goal and the number of indicators for each data exist in that moment in Eurostat database. The algorithm used here is: if there is at least one data point for the indicator in the database, it counts that data exist for that indicator.

Some cells in column **Available** have comments (information) that show how many “global” indicators are within that SDG goal. These are indicators that have data only at the EU (or global) level and not at the country level. If the row for the SDG goal is marked in light blue, it means that for the selected country there are data for all indicators for that goal. In the example in the picture below, it can be seen that for goals 1, 4, 5, 6, 7 and 11, for Serbia there are data for all EU SDG indicators (as of June 17, 2025).

If selected, the right side of the table will have pie charts. They show the availability of SDG indicators data in total and per each goal separately, for the selected country and year.

Below is such a table with charts generated for Serbia, to review the availability of EU SDG indicators for Serbia for 2025 year.
